ADDITION TO ARTICLE II:

SECTION VI: Paid firefighters and volunteer firefighters shall have a current CPR Certification. Any paid firefighter or volunteer firefighter who does not have a current CPR Certification will have one year from their starting date with Davis Lake Fire Protection Authority, Inc to obtain CPR Certification.

ADDITION TO ARTICLE IV

SECTION XX: DLFD shall assume all guarantees and financial responsibilities of contracts and agreements entered into by the DLFD Chairman of the Board with the approval of the Board of Directors.

ADDITION TO ARTICLE III

SECTION XIX: Any member (paid or volunteer) of the Davis Lake Fire Protection Authority, Inc that has disciplinary action taken against them by the Davis Lake Fire Protection Authority, Inc has the right to appeal that disciplinary action to the Davis Lake Fire District, Inc Board of Directors. The Board of Directors need only a quorum present to hear the appeal.

Jim Garrett moved to accept the addition. Sandra Wolfe seconded. Motion passed.
