- 1. Since there is no quorum, this meeting will be for informational purposes.
- 2. Voting on the March 2023 board meeting minutes will be suspended until the May 15, 2023 board meeting.
- 3. At the May 15, 2023 board meeting a change to Item 18 of the March 20, 2023 board meeting minutes will need to be voted on to change the actual cost for 100 new firefighter patches to \$310.00.
- 4. Bank balances as of March 31, 2023: PNC \$11,518.77, PNC Money Market \$15,001.35, Regions \$89,613.91 and Truist \$62,235.41.
- 5. Chief Briggs reports 9 calls since the March 20, 2023 board meeting. Year to date call total is 75.
